Hawki Annual Benefit Maximum

Effective May 31, 2025, the Hawki annual benefit maximum (ABM) will expire. All prior authorizations and dates of services claims on June 1, 2025, and thereafter will not have an ABM applied. <u>Learn more</u>.

Reminder: Annual Choice for DWP and DWP Kids

The annual Open Choice Period for eligible DWP and DWP Kids members is now open through June 18, 2025. During this time, eligible DWP and DWP Kids members can switch their dental carrier for any reason. Any dental carrier changes made during this period will be effective July 1, 2025, or later.

Updated Office Manual and Uniform Regulation

Special Health Care Needs

The <u>Delta Dental Special Health Care Needs Benefit</u> provides additional services for your patients with physical, developmental, mental, sensory, behavioral, cognitive, or emotional impairments that may affect their oral hygiene.

This benefit is standard on most Delta Dental of Iowa plans (excludes Medicare Advantage) and includes unlimited exams, up to four total cleanings per calendar year, and treatment delivery modifications including anesthesia/sedation. Eligibility must be added by the provider via the secure <u>Dentist</u> <u>Connection</u>. Providers can add the benefit(s) by navigating to "Add Special Health Care Needs Benefits" via the Eligibility tab.



Enhanced Benefits

Depending on the benefit plan, your Delta Dental patients may be eligible for Enhanced Benefits, which differs from Special Health Care Needs.

Enhanced Benefits are available for patients undergoing cancer-related chemotherapy and/or radiation, diabetes, high-risk cardiac conditions, kidney failure or dialysis, periodontal disease, pregnancy, or suppressed immune systems. Benefits include additional cleanings and fluoride applications. Providers can add the benefit(s) by navigating to "Add Health Conditions for Enhanced Benefits" via the Eligibility tab. Members can also add their health condition for Enhanced Benefits via the Delta Dental Member Connection.
