Claim Tip: Radiograph Submission Reminders for Implant Procedures



When submitting claims or predeterminations for implants and implant procedures, please be sure complete documentation is attached with your claim. Attachment requirements include a narrative, treatment plan and a radiograph - preferably a current full mouth series. If a current full mouth series is not available, you should include a current panoramic radiograph. A periapical radiograph may be acceptable for a single implant/implant procedure if tooth charting is supplied.


