Dental Education Loan Repayment Programs

What is the Loan Repayment Program?

The Delta Dental of Iowa (DDIA) Loan Repayment Program offers a \$50,000 award for the repayment of dental education debt to be used over a three-year grant period. The Loan Repayment Program was developed in 2002 and is funded solely by DDIA, offering one \$50,000 award per year.

What is the FIND Program?

The Fulfilling Iowa's Need for Dentists (FIND) project is an expansion of the loan repayment program. The FIND project works to stimulate community matching funds and promotes the loan repayment program to targeted communities in partnership with the state of Iowa. The program offers up to \$100,000 for dental education debt over a five-year period. This includes \$75,000 in funding from DDIA and the state of Iowa, and up to an additional \$25,000 in community match. *Note: A minimum of \$5,000 in community match is required.*

Who may apply to the Delta Dental of Iowa and FIND Loan Repayment Programs? Dentists who are:

- Fully trained and licensed (or in the process of becoming licensed)
- Interested in a public health role, but in a private-practice setting
- Committed to serving in a rural or underserved area in Iowa
- Working full-time (minimum 32 hours/week)
- Willing to allocate 35% of patient load to the underserved during program period (e.g., elderly, very young children, nursing home residents, Medicaid and Dental Wellness Plan members, non-insured, etc.)

Dentists must also have dental educational debt more than the total award amount (\$50,000 or \$100,000)

Enter your license number or plans for licensure. *Character limit: 250*

Upload your resume. File size limit: 2 MB

Upload three letters of reference. *File size limit: 2 MB (per file)*

Upload loan verification documentation. File size limit: 2 MB

Your application will be scored according to:

- Responses to questions above
- Underserved Iowa location selected
- Resume and letters of reference

All applications are reviewed by a DDIA committee, which includes representation from the DDIA board of directors and the Iowa Department of Public Health, and also reviewed by an external committee appointed by the Community Foundation of Greater Des Moines.
